
# Jackson County, Missouri – 16.18 pounds methamphetamine and 2.49 pounds marijuana

On 07-21-2021, at 0700 hours, members of the MOWIN Task Force were working a commercial transportation facility when they became aware of an abandoned suitcase. A K-9 Officer indicated to the presence of narcotics in or around the suitcase. Attempts to locate the owner met with negative results. It was determined the passenger/suitcase was traveling from *New York*, *NY to Minneapolis*, *MN*. A search yielded **16.18 pounds methamphetamine and 2.49 pounds marijuana** (NSS# 16755676). #### Ellsworth County, Kansas – 18 pounds methamphetamine

On 07-09-2021, at 1704 hours, Kansas Highway Patrol stopped **2013 Chrysler 200**, California registration 7BCJ525, on eastbound I-70 near mile marker 224, for a registration violation. Contact was made with the driver, Alberto ZAPIEN, w/m, 12-16-1970, and passenger, Londy Patricia ROCHE, w/m, 02-05-1992, both residents of Los Angeles, CA. A search yielded **18 pounds of methamphetamine located inside** the front passenger door and both rear doors (NSS# 16734178). There were four packages with distinct markings on three of them. #### Russell County, Kansas – 5 pounds heroin

On 07-12-2021, at 0924 hours, Kansas Highway Patrol stopped a **2017 Dodge Caravan**, **Arizona registration CMH1433**, on eastbound I-70 near mile marker 189, for failure to maintain a single lane of traffic. Contact was made with the driver, **Jose Angel RAMIREZ-SEBASTIAN**, w/m, 01-08-1975, and passenger, Claudia RAMIREZ, w/f, 04-24-1978, both residents of Phoenix, AZ. The occupants indicated they were traveling from *Phoenix*, AZ to New York City, NY. A search yielded 5 pounds of heroin, located inside the rear sidewalls under the cup holders (NSS# 16734476).
