Job Description

This position manages the creation and enrichment of metadata representing the Libraries' digital and physical collections and other materials. This position is also responsible for working in coordination to establish best practices, standards and procedures for cataloging and/or metadata as required. The Cataloging/Metadata Librarian will perform original cataloging and catalog maintenance in all formats in a mixed RDA/AACR2 environment using the MARC standard and may work with other metadata standards and schemas (e.g. BIBFRAME) as the need arises. Key responsibilities include:

- Applies metadata to library and other materials records according to library designated standards with understanding of system capabilities and implications; materials may include print, microform, and electronic resources
- Serves as a point of contact for cataloging questions
- Provides quality control of cataloging, including conducting analysis of existing descriptive cataloging, subject
 assignment, classification, and authority records, and national utility records, thus ensuring that cataloging
 complies with required local and national standards
- Keeps abreast of emerging trends, innovations and best practices affecting library systems and catalogs, and of methods of electronic resources management and metadata standards
- Uses available tools, including MarcEdit and OCLC Connexion Client, to implement changes and enhancements to Sierra
- Coordinates with Cataloging and Metadata Librarian to create and maintain policies and procedures for bibliographic, holdings and item records within Sierra and for select digital resources stored outside of Sierra
- Serves as a subject librarian to designated academic departments and oversees the selection of materials in assigned subject areas
- Assists in collection development and evaluation; monitors pertinent portions of the acquisitions budget; works to develop and maintain good relations with faculty members
- Participates in the Library's instruction program
- Participates in professional activities, including university and library committees and task forces, and attends professional meetings
- Other duties as assigned by direct supervisor
